4) <u>Terms and Conditions for the Grant of Waste Management Services</u> <u>Registration Certificate</u>

Upon receipt of a duly completed application form, the Goa Waste Management Corporation (GWMC) will undertake the following steps to process the grant of an Agency/Contractor Empanelment Certificate:

- 1. Verify the application details and supporting documents.
- 2. Conduct a thorough evaluation of the applicant's eligibility and financial viability.
- 3. Assess the applicant's site, resources, infrastructure, and operational plans if required.
- 4. Review and validate the applicant's waste management experience, the Agency/Contractor applying for Empanelment Certificate shall submit all the documents required as per the prescribed format in the application form in sealed hardcopies to GWMC office. If the Agency/Contractor fails to submit any document, then his application shall be deemed incomplete and may lead to rejection without any refund in application fees.

Upon successful completion of these steps, the GWMC will issue an Agency/Contractor Empanelment Certificate to the applicant.

NOTE:- In addition to the fines contemplated in Solid Waste Management Rules 2016, Goa Non-Biodegradable Act 1996 and successive its amendments, if the Agency/Contractor is found non-performing or GWMC receives complaints pertaining to mismanagement of waste or any other case etc pertaining to the agency/contractor, GWMC shall reserve the right to levy a fine of Rs.5000/- for 1st offence and Rs.10,000/- for 2nd offence. If any further complaint is received, then GWMC shall reserve the right to blacklist the agency/contractor and shall be prohibited from reapplication for a period of 1 year from the date of blacklisting.
